- 1. Boat cushions for bed much thicker.
- 2. Improve heating/ac and add vent in main salon.
- 3. Small Washer & Dryer next to master bathroom where there currently is a stack of towels on shelves. Leave room at the bottom for a cat litter box.
- 4. Boston Whaler Dinghy

- 5. Additional Fuel & Water Tanks
- 6. Satellite Telephone working with (used to work with 9600 baud modem) extra connection for modem..
- 7. Cellular Telephone with additional cards for usage
- 8. Crew list review
- 9. Manuals for everything on the ship.
- 10. Checklist (Daily, weekly, monthly) and a departure/arrival checklist.
- 11. Appropriate flags for sailing and registration and all other paperwork needed for boat. One of house safes can be placed under Master Bedroom Bed (securely attached).
- 12. Solar Panels & Wind Generator (with additional battery storage) for extended use of all electrical and electronic equipment on boat.
- 13. Consider making aft covering that is currently canvas fiberglass to give even more room for solar panels and to lessen wear & tear on boat.
- 14. Cushion inside aft, starboard & port, pontoons for docking of Boston Whalter.
- 15. Consider extending Radar Range of Unit and perhaps a backup Loran or other device for navigation.
- 16. Navigation Computer & Software for global navigation.
- 17. Backup Charts for Navigation.
- 18. (Note To Marc) Flat Screen & Keyboard For Office Area.
- 19. Extend & Secure area for Laser Printer attachable via a 10/100 LAN to Navigation Computer & any other computers on desk. 10/100 ** This should be connected via Ethernet and be a COLOR LASER printer with extra toners and paper for Weather fax, faxes, etc. required for Boat Computer. Best Place for Ethernet Hub and Printer is probably far left portion of desk, secured to desk and resting on shock absorbing material (springs, etc.).
- 20. Arrival of 3rd Original Portable Computer that was stolen when Fed Ex'd, When will replacement arrive?
- 21. Arrival of additional portable computer for house sent by Matt via Fed Ex. (The one that was to be ML's that I asked to be sent here.) Will be used as Marc's 3rd computer.
- 22. Computer chair for office area on boat.
- 23. House finally finished.
- 24. Louis Vuitton Luggage sent to be cleaned, repaired & reconditioned and then put back in storage.
- 25. Dent in Jeep repaired.

- 26. License plates, Insurance & all other necessary paper work for ownership of Jeep and Mercedes.
- 27. All Insurances, paperwork, etc. for ownership of house, boat, furnishings, cars, etc.
- 28. Final Completion Date of Boat for any global cruise.
- 29. Final completion date of house.
- 30. Once again, make copy of Marc's key-chain including garage clickers for Chad & Brock of all keys & clickers.
- 31.Occasional Driver for Marc to go places in mornings (when Chad & Brock are sleeping or unavailable to take him places (a driver).
- 32. Gate has problems opening and closing. Clear track or other recommendations.
- 33. Theater Room needs wood flooring to match offices.
- 34. Brock's Office couch/bed cushions cleaned. Spray to keep cat from pissing there.
- 35. Safety Box big enough to hold long safe materials in boat. Waterproof and sealed for NO moisture.
- 36. Show Bernardo various painting & hole coverings that need to be completed. Include lighting that has problems. Include Brock's Office problems with electrical (goes out for no apparent reason on occasion and breaker can't be reset).
- 37. Heater/AC in Marc's Office is not working properly. Heating does not work well, if at all.
- 38. Visiting planned for Chad's Brother & Brock's Brother. Secure travel plans. Explanation to them of VERY important issues with respect to travel, seeing us, security coming and going and what to say when coming, when here, when back. This should happen as soon as possible. This should be coordinated with either Matt, (Not sure about Mike Laurie, will leave that for Chad to decide), legal team, etc. Marc can NOT travel so they have to come here.
- 39. (CHAD ONLY) PGP on machines. Erasable on reading (messages automatically erase upon sending or reading) of messages of rotating Email boxes. PGP on recipient's machines. HIGHEST encryption method used. Chad should make list of Email addresses that can be receive/send such encrypted data and recipient list.
- 40. Emergency Medical Supplies. Besides ordinary medical supplies both on boat and in house, remember medication makes Marc's blood thin and even small cuts can lead to massive bleeding. The reverse of this is that most other illnesses (colds, etc.) are less likely for him but still needed for Chad & Brock. A very complete and extensive medical kit

- should be installed in both locations. CPR instructions, Black-out instructions and Physicians Desk Reference (Book) and other Medicial Books included.
- 41. Theater projector has green dot that is on screen at all times. It has been this way since being fixed.
- 42. Conference between Chad & Brock to draw up a list of things that would improve everyone's mental, physical and long-term well being. Additional personnel? Strategies? Locations? Individual fixes for each individual (as they will in all probability be different).
- 43. All issues are to be gone over with Bernardo & Chad or Brock. Chad & Brock should co-ordinate with each other. COMMUNICATE. Fix it so the Wizards staff can once again be functional and relief from these duties accomplished. Questions, problems, etc. are to be fixed between these two due to Marc's health. Goal is zero stress to Marc. Marc stresses due to medication side effects, help eliminate by proactive methods.
